## British Columbia Golf Membership Classes

CLASSES OF MEMBERSHIP (as indicated on page 10 of British Columbia Golf By-Laws)

## Category I

A club that owns or leases a golf course and maintains on a regular and continuing basis a junior, men's and women's membership and golf committees for the benefit of the members of such club, which has been approved by the Board for membership in accordance with the ByLaws.

## Category II

A group with a minimum number, as set by Golf Canada, of individuals who have become organized for the purpose of playing golf together without owning or leasing a golf course, which has a name and an organizational document acceptable to the Board and which has been approved by the Board for membership in accordance with the By-Laws.

## Category III

A golf course that is operated for the convenience of the public and allows on a regular or continuing basis affiliated Category II groups to be based on the course for regular play and competitions amongst members of the group and that has been approved by the Board for membership in accordance with the By-Laws

## Category IV

A golf course that is operated for the convenience of guests or the public and does not maintain on a regular or continuing basis a junior, women's and a men's membership or golf committee for the benefit of its members.
"Member" shall mean a person who has golfing privileges at the Member Club. Golfing privileges include, but are not limited to, annual dues, punch cards or passes, season passes, annual passes or annual passports.

## BRITISH COLUMBIA GOLF MEMBERSHIP POLICIES

## Membership Fees:

Fees are payable for each individual member.

## Membership Cards:

The 2017 Membership card replaces all previous Golf Canada/British Columbia Golf cards. A golfer playing in events may be required to provide a printed copy of their handicap record, which can be printed from the Golf Canada scoring center.

## Payment Due:

Fees are due June 1st, 2017 payable to British Columbia Golf.

## Payment Overdue:

British Columbia Golf must receive payment for all membership fees no later than the 1st day of June, 2017. Any member of a Category I,IIIIII or VI club, whose payment has not been received by June 1st, or has not made alternative arrangements, will not be eligible to enter British Columbia Golf Championships and may lose access to the Golf Canada Handicap System.

## Penalty for Late Payment:

Interest may be charged at 1\% per month on outstanding balances. Any accounts still in arrears will not be renewed the following season until paid in full.

## Membership Increases:

Membership fees are required to be paid for new or additional members; if a new member joins, fees must be paid immediately.

## Final Adjustments:

Adjustments to membership numbers must be reported to British Columbia Golf no later than July $\mathbf{1 5}^{\text {th }}, \mathbf{2 0 1 7}$. In the event of a decrease in membership, a credit will be issued and applied towards the following year. NO ADJUSTMENTS WILL BE ACCEPTED AFTER July 15th, 2017 (except new members).
